

2. The Court is not ruling on the Motion for Remand and Abstention [Doc. 11] and believes such motion should properly be heard and determined by the court to which this adversary proceeding is being transferred.

IT IS, THEREFORE, ORDERED that the Motion to Transfer Adversary to Another District (Southern District of New York) [Doc. 21] be, and the same hereby is, granted.

IT IS FURTHER ORDERED that the above-styled cause, together with all claims and causes of action therein, be transferred to the United States Bankruptcy Court for the Southern District of New York.

IT IS FURTHER ORDERED that the Clerk of this Court transmit to the Clerk of the Bankruptcy Court for the Southern District of New York, a certified copy of this Order and all pleadings and papers on file in the clerk's office relating to this proceeding.


