**NOTICE OF PLAINTIFF'S MOTION FOR PARTIAL SUMMARY JUDGMENT ON
CERTAIN ASSETS LOCATED IN THE SHREVEPORT PLANT**

PLEASE TAKE NOTICE that upon (i) the accompanying Memorandum of Law in Support of Plaintiff Motors Liquidation Company Avoidance Action Trust's (the "**Avoidance Action Trust**") Motion for Partial Summary Judgment; (ii) the accompanying Rule 7056-1(b) Statement of Undisputed Material Facts; (iii) the Declaration of Eric B. Fisher in support of Plaintiff's Motion for Partial Summary Judgment, all filed herewith, together with the exhibits identified therein and annexed thereto, the Avoidance Action Trust hereby moves this Court, pursuant to Rule 56 of the Federal Rules of Civil Procedure, Rule 7056 of the Federal Rules of Bankruptcy Procedure, and Rule 7056-1 of the Local Rules of Bankruptcy Procedure for the United States Bankruptcy Court for the Southern District of New York for entry of an order granting partial summary judgment in favor of the Avoidance Action Trust ruling that General Motors Corporation ("**Old GM**") did not grant a security interest for Defendants' benefit in the 7,801 assets identified in Old GM's June 2009 fixed asset ledger with an in-service date prior to November 29, 2006 located in the Old GM plant in Caddo Parish, Louisiana (the "**Shreveport Plant**").
