THE RECORD IN CONNECTION WITH THE APPEAL BY
JOHN MORGENSTEIN, MICHAEL JACOB, AND ALANTE CARPENTER

Pursuant to Rule 8006 of the Federal Rules of Bankruptcy Procedure, the Motors
Liquidation Company GUC Trust (the "GUC Trust"), formed by the above-captioned debtors
(collectively, the "Debtors")¹ in connection with the Debtors' Second Amended Joint Chapter
11 Plan, dated March 18, 2011 (as may be amended, supplemented, or modified from time to
time, the "Plan") submits the following counter-designation of additional items to be included in
the record in connection with the appeal of John Morgenstein, Michael Jacob, and Alante
Carpenter ("Appellants") from the January 18, 2012 Decision and Order on Motion to Dismiss
(Adv. ECF No. 42) (the "Decision and Order") and the January 18, 2012 Judgment (the
"Judgment") (Adv. ECF No. 43) of the United States Bankruptcy Court for the Southern
District of New York (the "Bankruptcy Court") (Gerber, J.) granting the Amended Motion to
Dismiss Plaintiffs' Complaint for Revocation of Discharge and, in the Alternative, Motion to
Strike Class Allegations (Adv. ECF No. 20) (the "Motion to Dismiss") and dismissing the
Complaint for Revocation of Discharge (the "Complaint") (Adv. ECF No. 1).

STATEMENT OF ISSUE ON APPEAL

Did the Bankruptcy Court err when it entered the Decision and Order and determined that it could not partially revoke the Plan?²
