# ORDER GRANTING DEBTORS' 166th OMNIBUS OBJECTION TO CLAIMS (Duplicate Debt Claims – Industrial Revenue Bonds)

need be provided; and the Court having found and determined that the relief sought in the 166th Omnibus Objection to Claims is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the 166th Omnibus Objection to Claims establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED that the relief requested in the 166th Omnibus Objection to Claims is granted to the extent provided herein; and it is further

ORDERED that, pursuant to section 502(b) of the Bankruptcy Code, the claims listed on **Exhibit "A"** (the "**Order Exhibit**") annexed hereto under the heading "Claims to be Disallowed and Expunged" (collectively, the "**Duplicate Debt Claims**") are disallowed and expunged; and it is further
